

**Ryan's Run Homes Association
Board of Directors Meeting
Memorandum**

August 12, 2025

The Ryan's Run Homes Association's Board of Directors (BOD) last met on April 17, 2025. At that meeting it was suggested that the 2025 Annual Assessment Fee of \$50 be waived or suspended for this year due to the lack of designated general fund usage at this time and the large amount of the fund (approximately \$5,000). Since an Annual Membership Meeting has not occurred this year to discuss this matter, and the due date for the annual fee of August 15th is quickly approaching, the Board decided to vote on this matter to give direction to the membership.

On July 28, 2025, an email was sent to the Board members requesting their vote to waive or suspend the 2025 Annual Assessment Fee. The Board members voted unanimously (7-0) in favor of waiving/suspending the Annual Assessment Fee for 2025. Attached are the electronic responses by the Board Members to document their votes.

This memorandum will be posted to the Association's website under Board of Directors Meeting Minutes to document the decision. An email will also be distributed to the Membership to advise them of this decision and to confirm that the 2025 Annual Assessment Fee is being waived/suspended for this year. A hard copy of the advising email will also be placed in each member's mailbox, since some members may not monitor their email box on a continual basis. The Annual Assessment Fee for 2026 and moving forward will revert to the normal \$50/year fee due on the 15th of August of each year.
